MANAGEMENT'S DISCUSSION OF MONTHLY RESULTS

Information on trends and events in the marketplace of the issuer, which may, in the issuer's opinion, have important consequences in the future for the financial condition and results of the issuer:

The biogas business is still supported area in Czech Republic. The agricultural chamber works on continuation of investment support plans during winter period.

Energy Produkt Plus is building its own projects. Biogas plant Suchdol already produces sufficient amount of gas for the first start. Biogas plant Cihost is finishing the building part and the fitting of technology equipment was already initiated. During these days two cogeneration units will be delivered.

The biogas plant Zavidkovice is under construction to increase the capacity to 1MW. The work will finish in June. There will be installed new technology of bioextrusion, which enable to raise biogas production from the current raw materials for 25%.

The BGS Energy Plus acquired a 40% equity interest in the project company Mlyn Okor, which holds all project rights for 590kW biogas power plant located in the municipality of Skury. The total investment costs will amount to CZK 56mio, the subsidy will be 30%. The biogas plant should be finished in 4Q 2011.

In the period covered by the report there was no use of funds raised from private placement.
