Information on trends and events in the marketplace of the issuer, which may, in the issuer's opinion, have important consequences in the future for the financial condition and results of the issuer:

In the beginning of 2nd half of 2010 the biogas sector has attracted the huge interest from the agriculture producers. It was mainly caused by the subsidies from the Ministry of Agriculture (including subsidies from EU) as about double number of biogas projects were supported in comparison with previous years.

It is also possible to prepare new biogas projects and to apply for the grid connection as the capacity of electricity network is not blocked by unrealistic photovoltaic projects that will not be realized till the end of current year.

The government also started the discussion of The Renewable energy act draft in August. The new legislation defines the limits for renewable energy sources. The biogas energy production should increase for 239% during next ten years, which is the highest growth in the area of renewable energy sector.*
