

MANAGEMENT'S DISCUSSION OF MONTHLY RESULTS

Information on trends and events in the marketplace of the issuer, which may, in the issuer's opinion, have important consequences in the future for the financial condition and results of the issuer:

The BGS Biogas works hard on some biogas plants for clients which were initiated during the spring 2012. We have finished the biogas plant Havlickova Borova (740kW) three months before the agreed deadline. The biogas plant will be given to our customer during this month including working cogeneration units and producing energy. The BGS Group is building and will finished totally cca 8MW of the installed energy production this year.

Till the end of the year we should finish our own biogas plant Ovesna Lhota (620kW). This biogas plant will be the fourth in our own biogas plants portfolio. (the sixth, including the biogas plants owned partially by BGS Group).

We are also going on possible cooperation in the biogas plants building and operation. If the negotiations would be succesfull, we can realize the projects (500kW, 620kW and 1MW) during the first half of the year 2013.

In the period covered by the report there was no use of funds raised from private placement.
