

#### MANAGEMENT'S DISCUSSION OF MONTHLY RESULTS

Information on trends and events in the marketplace of the issuer, which may, in the issuer's opinion, have important consequences in the future for the financial condition and results of the issuer:

BGS EP contractually finished the process of acquisition of Forest-Servis, Ltd. Thus expanding its activities mainly on specialized truck transport, retail sales of forestry and gardening technologies and finally services for trucks repairs. Synergies with other parts of the group will use the existing activities, which is expected to grow revenues at FS next year by 30%.

In July the project of specialized service centers cogeneration units was also completed. BGS Biogas has a new department specializing in the restoration of gas engines.

The second machine Claas harvester roughage was bought which leads to strengthened service in the agricultural sector. Overall, the Group will reap BGS for their needs and services for customers around. 4.000 ha of feed.
